*For example, there were 4376 students with an Emotional Behavioral Disorder who were removed in one of three discrete cumulative categories indicated in the chart. Of the 4376, there were 654 removed ≤ 1 Day (654 ÷ 4376 = 14.945155393053%), 2798 removed 2-10 Days (2798 ÷ 4376 = 63.9396709323583%), and 924 students removed for greater than 10 days (924 ÷ 4376 = 21.1151736745887%).

*For example, there were 22047 students within the Black subgroup who were removed in one of three discrete cumulative categories indicated in the chart. Of the 22047, there were 4222 removed ≤ 1 Day ($4222 \div 22047 = 19.1499977321178\%$), 14448 removed 2-10 Days ($14448 \div 22047 = 65.5327255408899\%$), and 3377 students removed for greater than 10 days ($3377 \div 22047 = 15.3172767269923\%$).

Of the 30973, there were 6749 removed ≤ 1 Day ($6749 \div 30973 = 21.7899460820715\%$), 20025 removed 2-10 Days ($20025 \div 30973 = 64.6530849449521\%$), and 4199 students removed for greater than 10 days ($4199 \div 30973 = 13.5569689729765\%$).

*For example, there were 38275 students within the Non-EL subgroup who were removed in one of three discrete cumulative categories indicated in the chart. Of the 38275, there were 8328 removed ≤ 1 Day ($8328 \div 38275 = 21.7583278902678\%$), 24880 removed 2-10 Days ($24880 \div 38275 = 65.0032658393207\%$), and 5067 students removed for greater than 10 days ($5067 \div 38275 = 13.2384062704115\%$).
