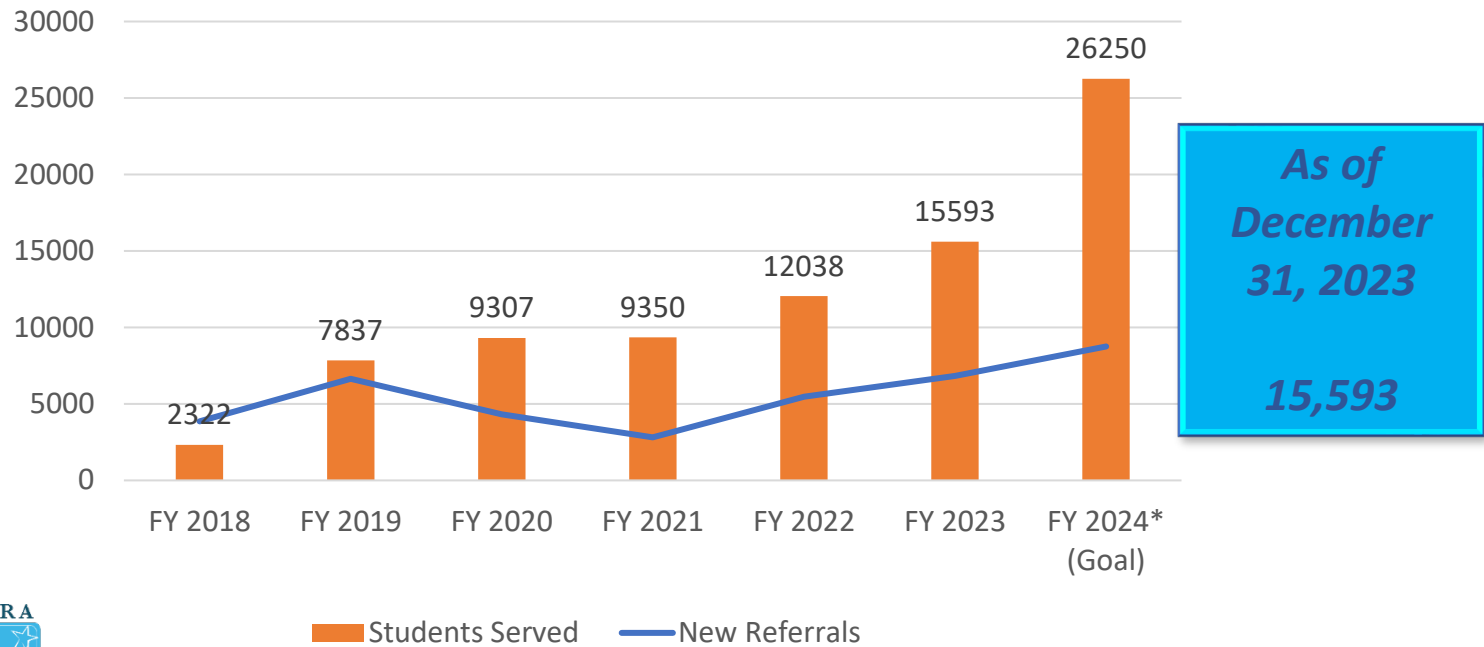

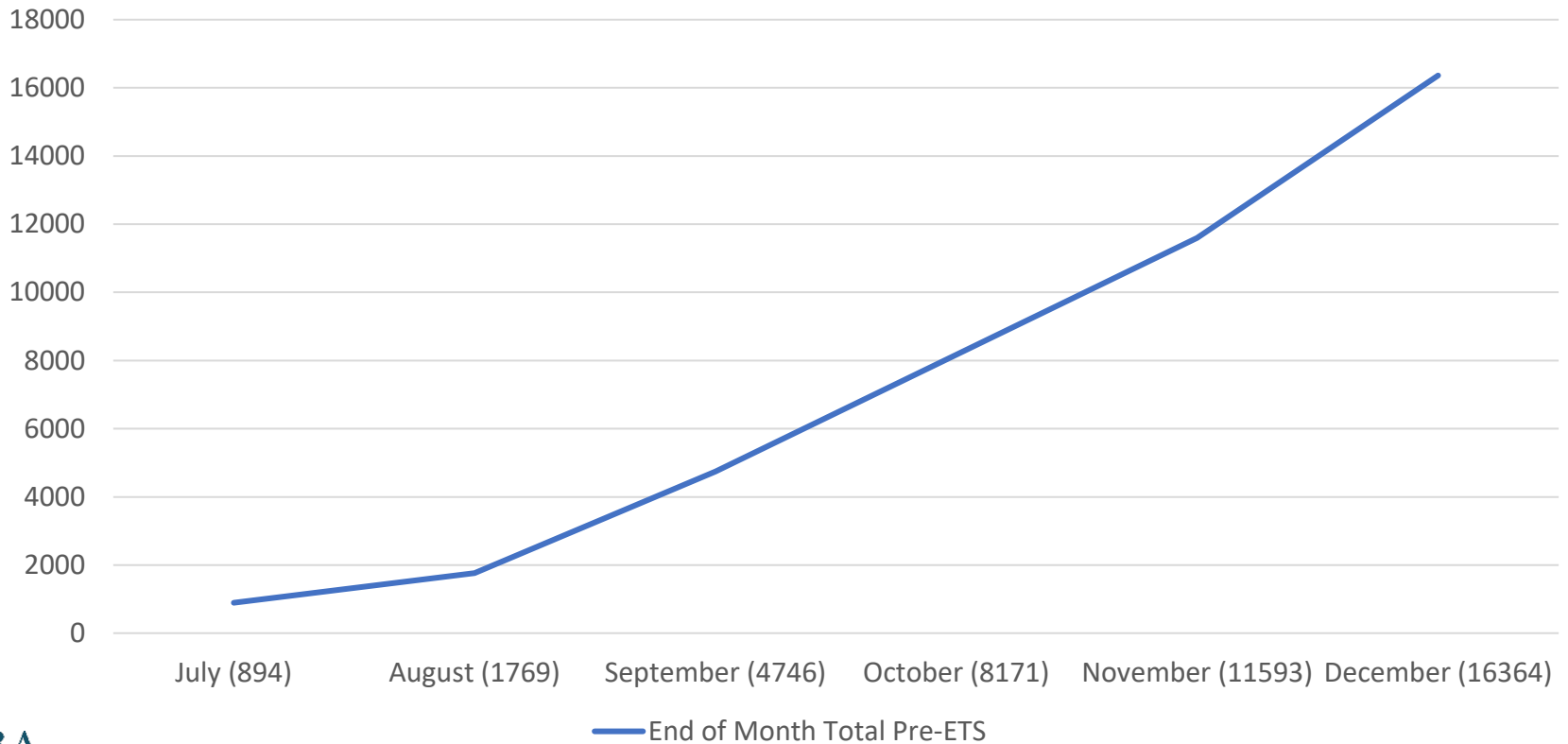

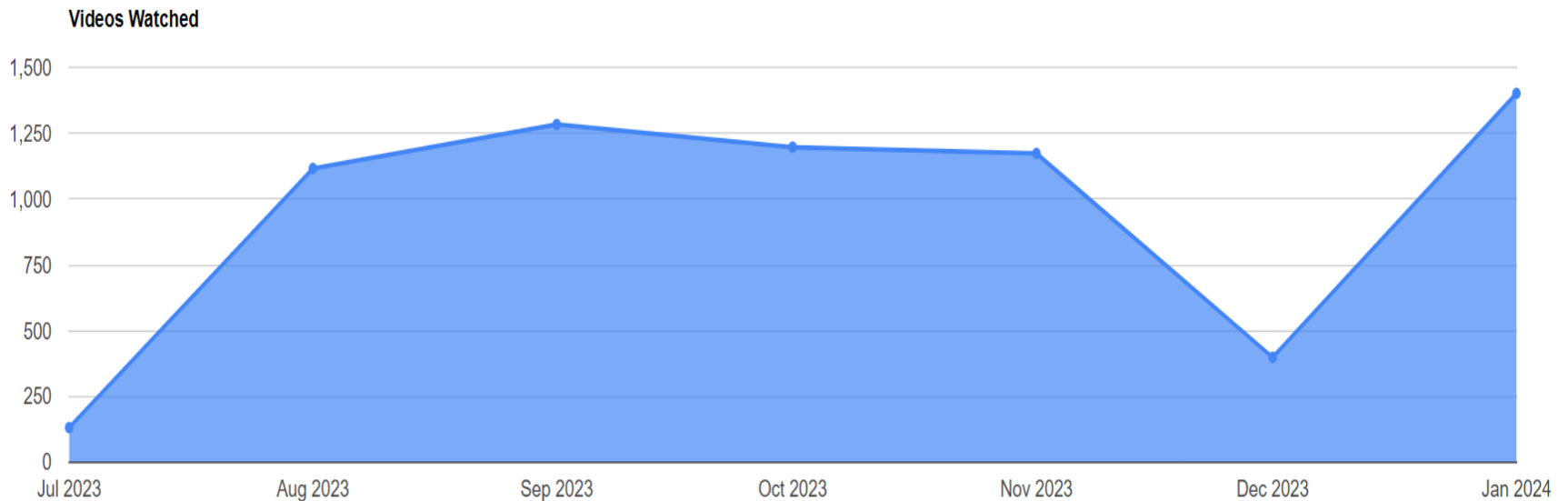
# Georgia Vocational Rehabilitation Agency Pre-ETS Updates 2023-2024

**Copy of IEP or 504 plan** required before a student can receive Pre-ETS

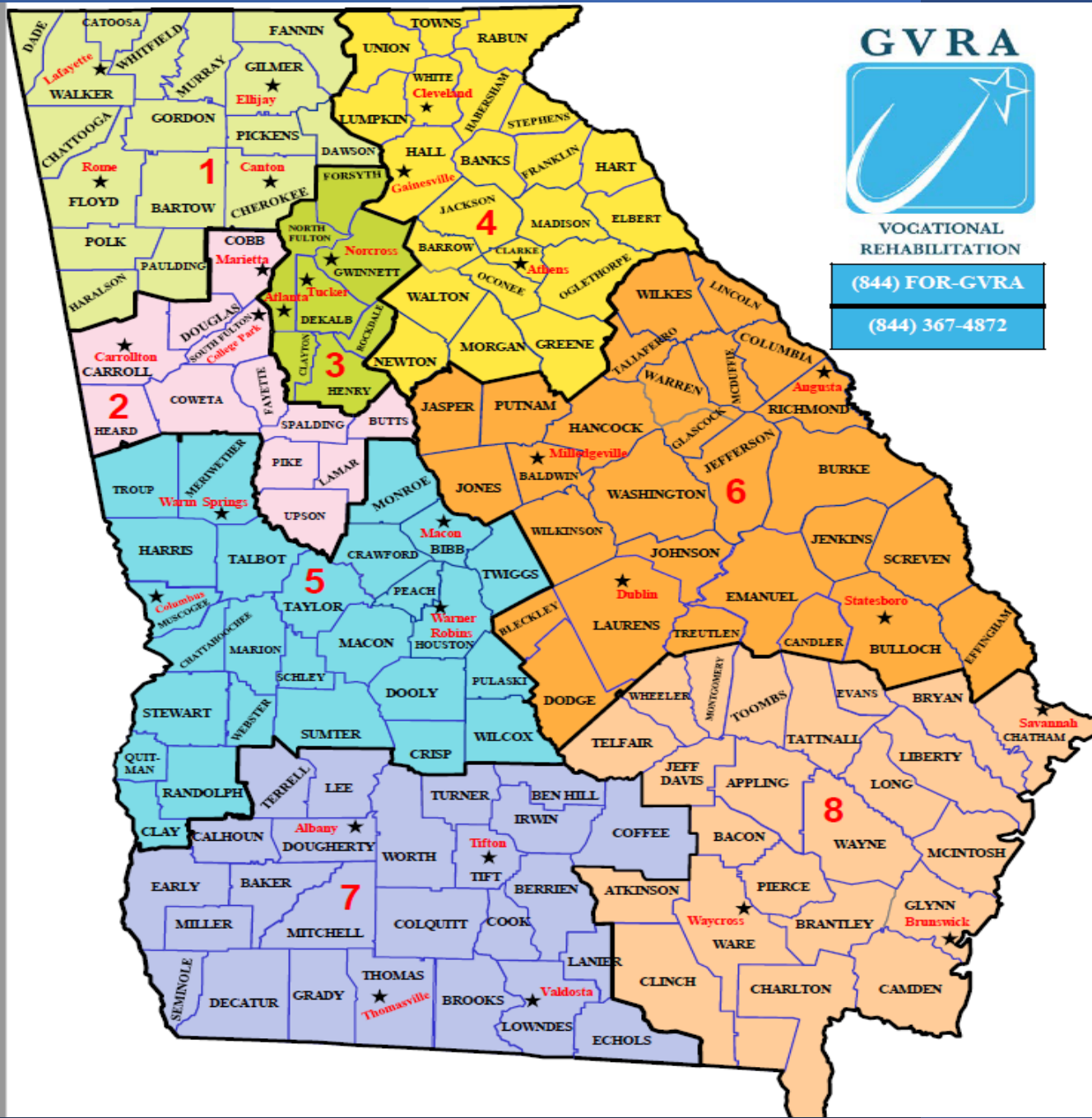
