Comment:

Additional Comment: There were four fully adjudicated hearings reported in Georgia as shown in item (3.2) above. None of these were completed in the timeline specified as indicated in 3.2 (a) and 3.2 (b) yielding a value = 0, including one expedited hearing included in the 3.2 total. The singular expedited hearing was fully adjudicated as indicated in (4.2) above with a value = 1. However, the expedited hearing was not completed within the expedited hearing timeline 3.2 (a), yielding a value = 0. As a result, 4.2 is > 3.2 (a).
