The State Board of Education acknowledges that the Georgia Charter School Commission is an independent body and that the State Board of Education has the authority to act or not act on official actions taken by the Commission. Let the record reflect that the State Board took no action on three of the charters approved by the Commission on February 17, 2011 as listed below:

- 1. Georgia Cyber Academy
- 2. Odyssey School
- 3. Provost Academy Georgia

With regard to Kaplan Academy of Georgia, the fourth charter approved by the Commission on February 17, 2011, the State Board has been informed that the Georgia Virtual Education Partners, the Charter Sponsor of the Kaplan Academy of Georgia decided on April 11, 2011 not to open the Kaplan Academy and to not execute a Charter contract with the Commission. The GaDOE and the members of the State Board have been in contact with the staff of the Commission and have been informed that Georgia Virtual Education Partners understands it would need to reapply for a charter if they elect to move forward in the future.
